C. COUNCIL REGULAR AGENDA

C-1. Discussion with the Orange County Appraisal District regarding property tax increases.

Scott Overton, Chief Appraiser with the Orange County Appraisal District gave an overview of the yearly process for the appraisal district. Mr. Overton stated properties are reviewed every three (3) years and explained how properties are appraised using market value. This year Mr. Overton stated they seen an average increase of sixteen percent (16%) for residential properties and discussed statistics on mobile homes, land and, commercial properties. Mr. Overton explained the audit the state of Texas requires for the appraisals. He went on to explain in the audit it is required they be within a five percent (5%) window of the property value study, or the schools can lose funding. Mr. Overton explained assessed value versus market value and the rules based on increases in homestead properties. He explained the appeals process for protesting the values. A discussion ensued.

C -2. Discussion regarding active grants for the City and providing a status of each one.

Katrina Jones, Finance Director discussed each active grant for the City. Ms. Jones referenced handouts in the Council binders. A brief discussion ensued.

C -3. Discussion and possible action to approve Resolutions appointing members to the Planning and Zoning Commission due to term expirations (3)

Robbie Hood, City Manager gave council the three (3) names for reappointment Jerry Aldridge, Fletcher Inzer and Anthony Foster. Mr. Hood explained all three (3) candidates are in good standing with the City.

A motion was made by Councilmember Barker, seconded by Councilmember McGowan, to Approve the Resolution reappointing Jerry Aldridge, Fletcher Inzer and Anthony Foster to the Planning and Zoning Commission. The Council voted four (4) for and one (1) opposed. The opposed vote was Gary Herrera, Ward 5. The motion carried.

A motion was made by Councilmember McGowan, seconded by Councilmember Weldon, for **Consideration of Adjournment**. The Council voted five (5) for and none (0) opposed. The motion carried, and the Regular Meeting of the Vidor City Council adjourned at 7:49 p.m.
