A. OPENING, PRESENTATIONS, AND CITIZENS COMMENTS

A -1. Call to order and the establishment of a Quorum

A quorum was present, and the Regular Meeting of the Vidor City Council began at 7:02 p.m., Mayor Songe presiding.

A -2. Invocation and Pledge to the United States Flag and the State of Texas Flag

Rod Carroll, Police Chief, gave the Invocation and led the Pledge to the United States Flag and the State of Texas Flag.

A -3. Citizen Comments

Adam Dilley, 1180 Orange Street, discussed information from Facebook and in the Examiner regarding the administration under the City Manager and the number of employees who have left employment in the past two years.

John D. Mesker, 2675 Lincoln, discussed an Open Records request he had submitted regarding the investigation of the City Manager and expressed his concerns regarding the response he received from the City Attorney.

Gary Herrera, 1018 Orange Street, recognized the hard-working people in the Street & Drainage Department and their efforts to improve the drainage in the City of Vidor. Mr. Herrera stated the City received over 7 inches of rain in the past two days with no big problems and commended all of the work that has been done and is being done.

A motion to remove the Special Called Meeting minutes from the Consent Agenda and approve the rest of the Consent Agenda was made by Councilmember Barker, seconded by Councilmember Herrera. The Council voted three (3) for and none (0) opposed. The motion carried.

A motion was made by Councilmember Barker, seconded by Councilmember Herrera, to bring the minutes from the Special Called Meeting back at the next meeting with more detail. The Council voted three (3) for and none (0) opposed. The motion carried.

C. COUNCIL REGULAR AGENDA

C-1. Presentation and discussion regarding Quarterly Report from the Vidor Chamber of Commerce

Atasha Quebedeaux, Vidor Chamber of Commerce, reviewed the different events sponsored by the Chamber in 2023, including a pageant, purse bingo, partnering with the City of Vidor for the Vidor Music Friendly Jam, trivia, and the Chamber banquet. Ms. Quebedeaux explained the purse bingo has become their largest fundraiser, and Hometown Holidays has now become a three-day event. Ms. Quebedeaux stated the lunches have gotten so big, they have had to go to a new venue (Woods Event Center instead of the Community Center).

Ms. Quebedeaux explained the membership has continued to grow every year and discussed goals for 2024. A brief discussion ensued regarding the relationship and communication which the Chamber offices being located in City Hall allows. Councilmember Herrera questioned if the Chamber still allows individuals who are not business owners to join, and Ms. Quebedeaux affirmed it is still in the bylaws. Councilmember Barker expressed her appreciation to the Chamber for working together, not only to show the citizens a united front, but working as one entity toward one goal. The Mayor and other members of Council agreed.

C-2. Discussion and possible action to approve an Ordinance calling for the Election of Three (3) Council Members in a City Election to be held on May 4, 2024, and setting up the procedures for the Election, the provisions for the Officers of the Election, establishing a Voting Precinct, and Polling Place, ordering a Runoff Election, if necessary to be held on June 15, 2024

Chris Leavins, City Attorney, explained this is an Ordinance calling for the election of three Council members to be held on May 4th, a runoff to be held on June 15th, if necessary, and. must be done by February 16, 2024

A motion was made by Councilmember Herrera, seconded by Councilmember Barker, to **approve the Ordinance.** The Council voted three (3) for and none (0) opposed.. The motion carried.

C-3. Discussion and possible action to approve a Resolution authorizing the City to enter into a Joint Election Agreement Services Contract with Orange County Elections Administrator for the 2024 Elections

Chris Leavins, City Attorney, explained the City usually joins with other entities in Orange County holding elections and shares the election expenses. Mr. Leavins stated this joint election contract allows us to contract with the Elections Administrator who puts on the election, and then bills us for our part.

Councilmember Weldon made a motion to **approve the Resolution**. Councilmember Barker seconded. The Council voted three (3) for and none (0) opposed. The motion carried.

C -4. Discussion and possible action to approve a Resolution amending the Personnel Policies as set forth in the Vidor Employee Handbook (Section 303 Vacation Benefits)

Jennifer Stevens, Payroll/HR, discussed the proposed changes and stated it will put into policy the current practice of allowing employees who have been with the City for ten or more years to sell back up to 40 hours of vacation once per year. Ms. Stevens also discussed the occasional need for employees to roll-over vacation and reviewed the proposed requirements for this. Councilmember Barker stated she would like it put into the policy who the City Manager goes to for approval of his/her vacation buy-back or carryover. A brief discussion ensued.

A motion to approve the Resolution amending the Personnel Policies with the addition of language stating the City Manager's requests are to be approved by the Mayor was made by Councilmember Barker, seconded by Councilmember Weldon. The Council voted three (3) for and none (0) opposed. The motion carried.

C-5. Consideration of Adjournment

A motion for **Consideration of Adjournment** was made by Councilmember Barker, seconded by Councilmember Herrera. The Council voted unanimously, and the meeting was adjourned at 7:36 p.m.
