A member of the audience that desires to speak during City Council's consideration of any specific agenda item is requested to notify City staff prior to the start of the meeting.

4. Discussion and consideration of action approving the Resolution designating signatories (Mayor) for the City of Vidor Employee Benefits Trust
5. Consideration and possible approval of a Resolution naming signatories for the City of Vidor, Texas Employee Benefits Trust checking account

7. Discussion and consideration of action awarding Lincoln Financial bid for Employee Dental Insurance
8. Discussion and consideration of action awarding Lincoln Financial the bid for Employee Life Insurance
