BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VIDOR:

Section 1. That said election was duly called, that notice of said election was given in accordance with the law, and that said election was held in accordance with the law; **Michael Thompson** was duly elected Councilmember for Ward 3 for the position referenced above of said City at said election, and said above named party is hereby declared duly elected to said respective office, subject to the taking of his oath and other requirements as provided by the laws of the State of Texas.”

A motion was made by Councilmember McGowan, seconded by Councilmember Barker, to **approve the ORDINANCE declaring the results.** The Council voted three (3) for and none (0) opposed. The motion carried

Nicole McGowan stated she is willing to continue as Mayor ProTem. Ms. McGowan made a motion to elect Michael Thompson as Treasurer.


