A quorum was present, and the Regular Meeting of the Vidor City Council began at 7:00 p.m., Mayor ProTem McGowan presiding.

Chris Leavins, City Attorney gave the Invocation and led the Pledges.

A motion was made by Councilmember Thompson, seconded by Councilmember Hill, to **APPROVE THE COUNCIL CONSENT AGENDA AS PRESENTED.** The Council voted four (4) for and none (0) opposed. The motion carried.

C. COUNCIL REGULAR AGENDA

C-1. Consideration and possible approval of a Resolution permitting Orange County Mosquito Control to fly at low altitudes in territory under their jurisdiction to abate mosquitos.

Chris Leavins, City Attorney informed council this is a resolution to approve the Orange County Mosquito Control to fly below the normal 1,000 feet altitude at about 500 feet for mosquito abatement.

A motion was made by Councilmember Hill, seconded by Councilmember Thompson, to **approve the Resolution.** The Council voted four (4) for and none (0) opposed. The motion carried.

C-2. Discussion and possible action to approve the Vidor Visitor Center Committee's recommendations for the nominees to the Vidor Walk of Fame.

Johnnie Andrus presented three (3) nominees for the Vidor Walk of Fame. They are Trubie Smith, Ted Slaughter, and John Hirasaki. Robbie Hood, City Manager explained to council these are the three (3) nominees selected by the Vidor Visitor Committee made up of the five (5) members previously appointed by Council. Councilmember Hill asked Ms. Andrus if Ted Slaughter was related to David Slaughter and Chris Leavins informed them this is his son. Councilmember Barker asked where the nominees are currently living. Ms. Andrus explained they at one time lived in Vidor. Councilmember Thompson asked what criteria Mr. Hirasaki fit into for the nomination. Mr. Hood explained there is a bullet point on the criteria stating-"the nominee must have received national recognition in his/her field".

A motion was made by Councilmember Hill, seconded by Councilmember Thompson, to approve the three (3) nominees presented. The Council voted four (4) for and none (0) opposed. The motion carried.

C-3. Consideration and possible action to approve an Ordinance of the City of Vidor, Texas amending the Code of Ordinances by amending Chapter 62 – Subdivisions, Article III – Improvements and Standards, regarding clearing of construction debris (including dirt and vegetation) from streets, drainage from properties and authorized variants; providing for repeal of conflicting ordinances; providing for severability; and providing for publication and an effective date.

Robbie Hood, City Manager explained any new develop will need to keep streets cleaned as laid out in the Ordinance. He then asked Chris Leavins, City attorney to explain further. Mr. Leavins stated the current Ordinance and the changes made are as follows: 62-160 explains no debris can be left on the roads, 62-161 covers that owners must take action to direct water from neighboring properties when under construction. Mr. Leavins explained this is also a State law, and 62-162 discusses a renewal process for variances by Council every three (3) years and this is being removed to provide that the variances can be brought to council as needed with no renewal provisions. Councilmember Barker asked for more detail on 62-161. A brief discussion took place. Mr. Hood explained there is some new construction happening that brought these changes about. Mr. Leavins then explained this item will need to be brought back for a second reading.

A motion was made by Councilmember McGowan, seconded by Councilmember Thompson, to **Approve the Ordinance**. The Council voted four (4) for and none (0) opposed. The motion carried.

C-4. Consideration and possible action to approve an Ordinance of the City of Vidor, Texas amending the Code of Ordinances by amending Chapter 70 – Traffic and Vehicles, Article I – In General, prohibiting heavy equipment that operates on tracks being used or driven on City streets; providing for repeal of conflicting ordinances; providing for severability; providing for a penalty; and providing for publication and an effective date.

Robbie Hood, City Manager explained this amendment is to prevent heavy equipment with tracks traveling on our roads and causing damage. Mr. Hood stated the city will allow for use of this equipment on streets with rubber mats and permission from the City. Chris Leavins, City Attorney explained this is to mirror what we do with commercial trucks and routes unless authorized by the city and makes this a traffic violation if not followed. Mr. Leavins then explained this will need to be brought back for a second reading.

A motion was made by Councilmember Barker, seconded by Councilmember Hill, to **approve the Ordinance**. The Council voted four (4) for and none (0) opposed. The motion carried.

Mr. Leavins explained this is an eight (8) year tax abatement period and decreases in increments over that period. Mr. Leavins added this has been a successful program since it started. Councilmember Hill asked how often individuals can submit for the abatement. Mr. Leavins explained this is a yearly process and any that are submitted after this approval will be added to the next year's requests. Councilmember Barker asked about the remodels and additions. Mr. Leavins explained the guidelines for this process. A brief discussion ensued.
