NOTICE IS HEREBY GIVEN THAT the Vidor City Council will meet in a *Special Called Meeting*, Thursday, the 15th day of August 2019, at 7:00 p.m. at Vidor City Hall, 1395 North Main Street, Vidor, Texas for the following purposes:

At this time, members of the audience may comment on any city-related subject not on the agenda. The Texas Open Meetings Act prohibits the Council from discussing items not listed on the agenda. A speaker may be directed to the appropriate department head for an answer to his/her question, or his/her concern may be placed on a future agenda for Council's consideration.

A member of the audience that desires to speak during City Council's consideration of any specific agenda item is requested to notify City staff prior to the start of the meeting.
