BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VIDOR:

Section 1. That said election was duly called, that notice of said election was given in accordance with the law, and that said election was held in accordance with the law; Nichole G. McGowan and Gary Herrera were duly elected Council Members for the positions referenced above of said City at said election, and said above named parties are hereby declared duly elected to said respective offices, subject to the taking of their oaths and other requirements as provided by the laws of the State of Texas.

Section 2. That no candidate for the position of Councilmember for Ward Three (3) received a majority of votes cast and a runoff election is hereby ordered, in accordance with the runoff election previously ordered under Ordinance Nos. 1419 and, as amended, by 1425, for June 18, 2022, between Michael Thompson and Ronnie Herrera for the position of Ward Three (3)."

A motion was made by Councilmember Herrera, seconded by Councilmember McGowan, to approve the **Ordinance declaring the results.** The Council voted four (4) for and none (0) opposed. The motion carried.
