Discussion and possible action to approve a Resolution approving the recommendation of the Selection Review Committee to award by resolution a contract with Traylor & Associates, Inc. for administrative services pertaining to the application and implementation, if awarded, of the City's 2023-2024 Texas Department of Agriculture TxCDBG grant and authorizing the execution of a contract.

Katrina Jones, Finance Director explained the grant and informed council Traylor & Associates were the only bid received. Ms. Jones told council she recommends Traylor & Associates as the administrator for this grant.

Katrina Jones, Finance Director explained the contract with Tyler Technologies informing council this will allow the City to go from using Incode 9 to Incode 10 and have access to a cloud platform.
